You will not be able to reserve a booth until a check has been received.

Theme

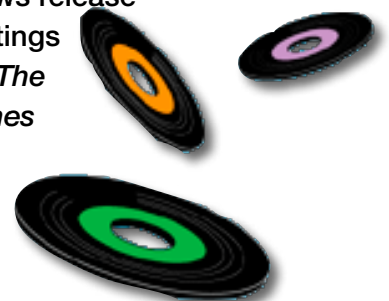

TERMS OF CONTRACT FOR EXHIBIT SPACE

Statement of Policy: All exhibitors regardless of size will be given opportunity, within reason, to present their product or service in the most effective manner to the audience.

A signed contract and payment in full is required before assignment of space can be made. All booths will be reserved on a first come, first serve basis. The Business Expo Committee will decide location of the booth at a later date. Space is limited to a maximum of two (2) booth spaces per exhibitor. Contract deadline is September 3, 2010.

All aisles and spaces not leased will be under the control of the Chamber of Commerce. All displays, distribution of literature and demonstrations shall be made inside the space contracted. No items may be placed in the aisle. Exhibitors may not sublet or share space without the knowledge and consent of the Chamber of Commerce. A least one person must staff booths at all times during show hours.

The Chamber of Commerce, Business Expo sponsors and the property owner disclaim liability for damages or losses due to fire, theft, accident, vandalism or other causes. The Chamber, Business Expo Sponsors, and the property owner will not be responsible for electrical or related failures. Exhibitors wishing to insure their goods must do so at their own expense. The exhibitor shall at all times protect, indemnify, save and hold harmless the Chamber, Business Expo sponsors and the property against any and all loss, damage, liability or expenses arising out of exhibitor's occupancy and use of Expo premises during or subsequent to the period of exhibition.

All exhibitors will observe move in and move out times.

Exhibitors will be allowed to move in starting at 1:00 p.m. to 8:00 p.m. on Wednesday, September 16th. All booths should be completely set-up by 8:00 p.m. that day.

No Exhibitors shall begin breakdown of booth or removal of exhibited material until the show is officially closed on Thursday, September 16th at 5:00 p.m. All exhibits must be removed by 9:00 p.m. Thursday, September 16th.

Electricity is available to the exhibit booths at a charge of \$25.00 per outlet.

Cancellation prior to September 10th will be eligible for a full refund. Cancellations after September 10th will not receive a refund.

No person or persons, other than exhibitors, will be permitted to conduct business on the floor without the express knowledge and permission of the Chamber of Commerce.

There will be no retail sales, cash exchanges or deliveries from any booth, except for the distribution of free samples and advertising items.

No smoking, no confetti.
